

**BOROUGH OF BROOKHAVEN
DELAWARE COUNTY, PENNSYLVANIA**

NOTICE is hereby given that the Borough Council of the Borough of Brookhaven, at a Meeting to be held at 7:00 P.M. on Monday, December 16, 2024, will consider the adoption of the final 2025 Budget and the Borough Tax Enabling Ordinances and Resolution. The Meeting will be held in the Council Chambers, 2 Cambridge Rd, Brookhaven, Pennsylvania 19015.

Anyone wishing to be heard with respect to the proposed Tax Ordinances and Resolution, proposed 2025 Budget, or any other business that may come before Council for the Borough of Brookhaven should be present at that time.

The proposed Ordinances and Resolution to be considered by Council are summarized as follows:

1. A RESOLUTION OF THE BOROUGH OF BROOKHAVEN, DELAWARE COUNTY, COMMONWEALTH OF PENNSYLVANIA SETTING THE TAX RATE FOR THE YEAR 2025. This Resolution sets the tax on real property at 3.50 mills on each dollar of assessed valuation. The Resolution also repeals, rescinds, cancels, and annuls all inconsistent resolutions.

2. AN ORDINANCE OF THE BOROUGH OF BROOKHAVEN, DELAWARE COUNTY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE ANNUAL SEWER RENTAL CHARGE FOR THE YEAR 2025 AND PROVIDING FOR COLLECTION OF SEWER RENTAL CHARGES. This Ordinance sets the sewer rental charges for each unit as follows: Zone 1=\$496.50; Zone 2=\$496.50; Zone 3=\$496.50; Zone 4=\$492.90; Zone 5=\$494.50. The Ordinance also sets the date for payment of on or before May 31, 2025, or such account is subject to a penalty in the amount of ten percent (10%) plus interest. The fee is to be collected by the Tax Collector. The Ordinance also repeals, rescinds, cancels, and annuls all inconsistent Ordinances.

3. AN ORDINANCE OF THE BOROUGH OF BROOKHAVEN, DELAWARE COUNTY, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING A REFUSE COLLECTION FEE FOR THE YEAR 2025 AND PROVIDING FOR THE COLLECTION OF THE SAME. The Ordinance sets the annual refuse collection fee at \$469.83 per dwelling in the areas of the Borough zoned R1A, R1, R2, and each dwelling in the R4 area that is located north of Edgmont Avenue and east of Brookhaven Road. The Ordinance sets the date for payment of on or before May 31, 2025, or such account is subject to a penalty in the amount of ten percent (10%) plus interest. The fee is to be collected by the Tax Collector. The Ordinance also repeals, rescinds, cancels, and annuls all inconsistent Ordinances.
